



## Memorandum of Understanding

Deutsche Welle, a public broadcasting institution formed under German law with its headquarters in Bonn, Federal Republic of Germany, represented by Mr. Carsten von Nahmen, Head of DW Akademie

- hereinafter "DW"

and

Ivan Franko National University of Lviv, with its headquarters in Lviv, Ukraine, represented by Prof. Melnyk, the Rector

hereinafter "IFNUL"

hereinafter "the Parties"

enter into this Memorandum of Understanding:

#### Preamble

DW and IFNUL agree to establish their relationship at corporate level, to provide a framework for cooperation in the context of the following thematic areas.


### § 1 Subject of Cooperation

DW, through its international media development and training centre DW Akademie, and Partner-University are committed to have agreed upon cooperation in the field of academic media education. Concrete measures will be jointly defined and developed by the Parties.

#### § 2 Fields of cooperation

The Parties agree to collaborate in the following fields: research projects and lecturer exchanges within the framework of DW Akademie's International Media Studies Program in the media field.





#### § 3 Focus of cooperation

The Parties agree to the following schedule of program.

DW will offer a four week visiting research and lecturer fellowship for one Professor in Germany. In addition to this, the coordinator from IFNUL gets free access to an exchange platform for knowledge transfer. This entails regular events for exchanging expertise with Professors and media professionals from the North and South. At the same time, the participants become part of a network of change agents for improvements in the university sector.

For the visiting research period, DW will cover the costs for flights and accommodation in Germany. This offer will be realized in the first two years of the collaboration.

## § 4 Confidentiality

Both, DW and IFNUL commit themselves to the principals of full confidentiality and non-disclosure in regard to all corporate documents and information made available by one of the parties to the other. This includes all persons involved in the collaboration for the time of duration of the agreement and after that.

#### § 5 Validity

This Memorandum of Understanding shall come into effect after the mutual signing of the Parties and shall be valid for three years. It can be replaced by another Memorandum of Understanding or officially cancelled by one of the Parties involved. The Memorandum of Understanding shall automatically be prolonged if neither of the Parties has cancelled it or if it is not being replaced by another Memorandum of Understanding.





# **Miscellaneous Provisions**

Any difference or dispute between the two parties shall be settled amicably without recourse to legal action except in maximum emergency and after direct consultation and negotiations with each other to end such dispute.

The Memorandum of Understanding shall be signed in two identical copies, one for each respective party. In the event of any conflict between the English and the other language versions, the English version shall prevail.
